1. General provisions:
一般規定：

1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2 No more than 18 specified residential properties under this “Information on Sales Arrangements” can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person.
