General provisions: 一般規定：</p> <p>1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons. 如同一份臨時買賣合約包括多於一個指明住宅物業，每一該等指明住宅物業之買方須由同一人士或同一組人士構成。</p> <p>1.2 No more than 5 specified residential properties under this “Information on Sales Arrangements” can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person. 不得有多於 5 個於本「銷售安排資料」下之指明住宅物業之買方為或包括公司、法團或非自然人之實體。</p>	

1.3 No more than 87 specified residential properties of the Development can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person. 發展項目不得有多於 87 個指明住宅物業之買方為或包括公司、法團或非自然人之實體。

1.4 A person may only be the purchaser of at most two specified residential properties in the Development (whether or not specified residential properties included in these Sales Arrangements). If a person is not the sole purchaser of but is one of the persons comprising the purchaser of a specified residential property, that person will also be deemed to be the purchaser of that specified residential property for the purpose of this paragraph 1.4.

2. On the First Date of Sale and thereafter:

2.1 Subject to “Other matters” below, First come First served. Persons interested in purchasing must personally attend the designated venue to select the residential property(ies) that the person wishes to purchase. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

(a) Prospective purchasers will be offered to view the selected specified residential property(ies), or comparable residential property(ies) if it is not reasonably practicable for such specified residential property(ies) to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.

準買家在簽署臨時買賣合約前，將獲安排參觀所揀選的指明住宅物業。如開放所揀選的指明住宅物業供準買家參觀並非合理地切實可行，則準買家在簽署臨時買賣合約前，將獲安排參觀與揀選的指明住宅物業相若的住宅物業。

- (b) The sale of the specified residential properties is subject to availability. Please note that the Vendor's admittance of any person to the designated venue or the waiting queue thereof, does not guarantee that that person will be able to purchase any specified residential property.

- (c) If on any Date of Sale, (i) Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 7 a.m. and 8 p.m.; or (ii) where the Vendor considers that there being an event affecting the safety or order or *public health* in the designated venue and/or the vicinity; or (iii) *the Hong Kong Government has imposed any restriction or issued any order relating to Coronavirus Disease 2019 ("COVID-19") which requires people (except for exempted persons) in Hong Kong or any part thereof to stay indoor (such as stay-at-home, movement control or lockdown order) and/or requires the closure of the designated venue*, then, for the safety of the prospective purchasers and the maintenance of order at the designated venue or for compliance with the said restriction or order relating to COVID-19, the Vendor reserves its absolute right to change, postpone the selection of specified residential properties and/or the Date of Sale to such other date, time, period, and/or place as the Vendor may consider appropriate. Details of the arrangement will be posted by the Vendor on the designated website of the Development < www.seasidesonata.hk >. Prospective purchasers will not be separately notified of the same.

- (d) Without prejudice to the generality of the above and the Vendor's absolute right stated in paragraph (c) above, in the event that Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the designated venue, and/or the vicinity of any of foregoing, unless the Vendor has announced other alternative arrangements, the procedures on any Date of Sale as referred to above (including the selection and sale of specified residential properties) shall take place at the following venue. The arrangements shall be subject to the Vendor's final decision which shall be binding on all persons:
