1. General provisions:

- 1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

- 1.2 No more than 4 specified residential properties under this "Information on Sales Arrangements" can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person.

- 1.4 A person may only be the purchaser of at most two specified residential properties in the Development (whether or not specified residential properties included in these Sales Arrangements). Persons interested in purchasing must personally attend the designated venue to select the residential property(ies) that the person wishes to purchase. - (a) Prospective purchasers will be offered to view the selected specified residential property(ies), or comparable residential property(ies) if it is not reasonably practicable for such specified residential property(ies) to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.

- (b) The sale of the specified residential properties is subject to availability. - (c) If on any Date of Sale, (i) Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at any time between the hours of 7 a.m. and 8 p.m.; or (ii) where the Vendor considers that there being an event affecting the safety or order or public health in the designated venue and/or the vicinity; or (iii) the Hong Kong Government has imposed any restriction or issued any order relating to Coronavirus Disease 2019 ("COVID-19") which requires people (except for exempted persons) in Hong Kong or any part thereof to stay indoor (such as stay-at-home, movement control or lockdown order) and/or requires the closure of the designated venue, then, for the safety of the prospective purchasers and the maintenance of order at the designated venue or for compliance with the said restriction or order relating to COVID-19, the Vendor reserves its absolute right to change, postpone the selection of specified residential properties and/or the Date of Sale to such other date, time, period, and/or place as the Vendor may consider appropriate.
