1. General provisions:

  - 1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

  - 1.2 No more than 2 specified residential properties under this “Information on Sales Arrangements” can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person.

  - 1.3 No more than 87 specified residential properties of the Development can be purchased by a purchaser which is or includes a company, corporation or entity which is not a natural person.

- (b) The Vendor has the absolute right to accept or reject any offer for the purchase of any specified residential property. Although a specified residential property may be available for tender on a Date of the Sale, it may become unavailable during that Date of the Sale because the Vendor may accept a previous tender for that specified residential property within 21 days after the close of such previous tender exercise. In such event, the Vendor will reject other offer(s) for that specified residential property.
