The Purchasers of such residential properties shall be entitled to this benefit only if the relevant Purchaser has signed the formal agreement for sale and purchase in accordance with the preliminary agreement for sale and purchase, and the Purchaser has paid 10% of the Transaction Price of the residential property in accordance with the date(s) as stated in the formal agreement for sale and purchase. The provision of the aforesaid Gold Tiger is subject to the terms and conditions prescribed by the relevant supplier. Subject to the terms and conditions of the relevant transaction documents.
