If the purchaser appoints the Vendor's solicitors to act on his/her behalf in respect of all legal documents in relation to the purchase including the agreement for sale and purchase and assignment and that Vendor's solicitors are also appointed to handle mortgage transactions, the Vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment.
