The Purchasers of such residential properties shall be entitled to this benefit only if the relevant Purchaser has signed the formal agreement for sale and purchase in accordance with the preliminary agreement for sale and purchase, and completed the sale and purchase in accordance with the formal agreement for sale and purchase and the Purchaser has duly paid the management fee of such residential property purchased for the first 2 months after execution of the Assignment. Subject to the terms and conditions of the relevant transaction documents.

Who is liable to pay the solicitors' fees and stamp duty in connection with the sale and purchase of a specified residential property in the Development:
